**PRIVACY POLICY** This Privacy Policy sets out how Nefful (Malaysia) Sdn Bhd (“Nefful”) and its holding, related and subsidiary companies, collect, store and handle personal information (as defined below) of individuals in accordance with the Personal Data Protection Act 2010 (“PDPA”) and the laws of Malaysia.

Please read this Privacy Policy to understand how we use the personal information we may collect from you.

By signing in Nefful’s relevant Application Form for Distributors and/or by providing your Personal Information to us, you are consenting to this Privacy Policy and the collection, use, access, transfer, storage and processing of your personal information as provided as follows:-

- 1) That all Nefful distributors hereby agree, consent and authorize Nefful (Malaysia) Sdn. Bhd. (Nefful) and its holding company/subsidiaries and overseas branch/associate offices and/or its authorized agents, servants or authorized third party to collect, record, hold, store, use and/or disclose or make available my/our personal data and information (including but not limited to the name, date of birth, identity card and/or passport number, company/business registration number, address, bank account(s) and credit/debit card numbers, fingerprints, marital status, family, education, occupation, contact information, financial conditions, position and bonus entitlement in Nefful and all other information which may be used to identify a natural person or legal entity, both directly and indirectly) for and in relation to the performance of your contract/membership with Nefful and within the specific purposes including as follows:-
  - a) to promote the direct selling of Nefful’s products, marketing activities, selling of goods, recruitment of members, calculation and payment of bonus and benefits and for all legal compliance and obligations required of Nefful and for all other lawful purposes deems fit by Nefful including tax declaration within and after the validity period of my contract/membership with Nefful;
  - b) to process and use your personal information in Malaysia and overseas through automated machine or non-automated ways and also to disclose or make available your personal data and information to Nefful’s holding company/subsidiaries and overseas branch/associate offices and/or its authorized agents, servants, members, distributors, banks, accountants, auditors, lawyers and other authorized third parties as Nefful deems fit, to sponsor or recruit new members, to develop and promote Nefful’s business and for all other activities necessary and incidental to Nefful’s business operation.
- 2) That all Nefful distributors hereby acknowledge and confirm your knowledge:-
  - a) that your personal data as aforesaid will be/is being processed by Nefful;
  - b) the purposes of the collection and processing of your personal data;
  - c) that you have the right to request access to and to request correction of and for the limiting of the processing of the personal data, to withdraw your consent hereto given and the manner to contact Nefful with any request, inquiry or complaint;
  - d) of the class of third parties that Nefful discloses or may disclose your personal data;
  - e) of the choices and means that were offered for limiting the process of personal data;
  - f) that it is obligatory for you to supply the personal data; otherwise your membership application with Nefful may not be processed and /or that your membership may not continue to be effective and that rights and benefits including bonuses will not be able to be enjoyed by you or paid to you;
  - g) that the phrase “processing”, “personal data” and other related phrases used here shall carry and/or include the meaning given to them under the Personal Data Protection Act 2010
  - h) Personal Data held by Nefful will kept confidential in accordance with Nefful’s Personal Data and Privacy policy to any applicable law that may from time to time be in force. All reasonable efforts and practical steps are made to ensure that any Personal Data held by Nefful is protected against any loss, misuse, modification, unauthorized or accidental access or disclose, alteration or destruction;
- 3) You understand and agree, any personal information that Nefful and its holding company/subsidiaries and branch/associate offices collect, process, use and transmit (including from the past, now or future), is confidential to Nefful and its holding company/subsidiaries and branch/associate offices; You shall abide and comply with the Personal Data Protection Act 2010 in Malaysia and all applicable laws, by-laws and Nefful’s rules and regulations in force in Malaysia when receiving using or transmitting such information and shall not use the information in any unrelated areas or in any unauthorized manner or to develop businesses other than Nefful’s business. You shall not transfer disclose or transmit any such information directly or indirectly to any unauthorized third party but to use disclose and transmit same strictly for the purposes as herein mentioned.
- 4) You acknowledge and confirm that all your personal data and information and third party information provided by you to Nefful and its overseas holding company/subsidiaries and branch/associate offices are correct and accurate in accordance with my/our best knowledge and has the relevant third party’s understanding, agreement and authorization and has been obtained legally. You undertake to indemnify and save Nefful harmless against all claims, losses, damages, penalties and fines arising or resulting from Nefful’s use or disclosure of such information. You further undertake to update and inform Nefful in writing as soon as practicable in the event of any change or variation to the personal data aforesaid data or information.
- 5) That this Privacy Policy shall be deemed to have been communicated to and brought to your attention prior to you signing the relevant distributorship application form and the providing by you of your personal information to us. This Privacy Policy may be varied or amended from time to time at Nefful’s absolute discretion and any amendment or variation thereto shall be deemed communicated to you upon the same being published in Nefful’s official website or by email or other forms of publication as it deems fit.
